CONSENT ORDER

Hafeez Khan, M.D. is licensed as a physician in Rhode Island. After a review of the above-referenced complaints by an investigative committee ("Committee") of the Board of Medical Licensure and Discipline ("Board"), the Director of the Department of Health makes the following:

FINDINGS OF FACT

1. Hafeez Khan, M.D. ("Respondent") has been a licensed physician since April, 2000; his license was last renewed in 2012, and is currently considered inactive. He practiced pain management in Smithfield and East Providence. His specialty is Anesthesiology.

2. The Committee found that Respondent entered into a settlement agreement with the Office of Inspector General of United States Department of Health and Human Services (OIG) in October of 2013.
3. The settlement agreement involved contentions on the part of the OIG that Respondent submitted or caused to be submitted claims to Medicare and Medicaid for services not rendered, overbilling and unbundling of CPT codes from 2006-2010.
4. Respondent did not admit liability, nor did OIG aver facts were not well founded.
5. Respondent denies any willful or deliberate misconduct in violation of any statute or regulation.

Based on the foregoing, the parties agree as follows:

1. Respondent admits to the jurisdiction of the Board.
2. Respondent has reviewed this Consent Order and understands that it is subject to final approval of the Board; and this Consent Order is not binding on Respondent until final ratification by the Board.
3. If ratified by the Board, Respondent hereby acknowledges and waives:
 - a. The right to appear personally or by counsel or both before the Board;
 - b. The right to produce witnesses and evidence on his behalf at a hearing;
 - c. The right to cross-examine witnesses;
 - d. The right to have subpoenas issued by the Board;

- e. The right to further procedural steps except for those specifically contained herein;
 - f. Any and all rights of appeal of this Consent Order; and
 - g. Any objection to the fact that this Consent Order will be presented to the Board for consideration and review.
4. Respondent hereby agrees to a Reprimand based on the facts referenced above.
 5. Respondent agrees to register for and attend a Board approved course within 180 days of ratification of this order, such as CPEP Probe course and release records of this course to the Board.
 6. Respondent agrees to pay an administrative fee to the Board for costs associated with investigating this complaint. Respondent shall submit to the Board within sixty (60) days a check made payable to the Rhode Island General Treasury in the amount of \$1200.00.
 7. In the event that any conditions of this Consent Order are violated after it is ratified, Respondent shall be subject to further disciplinary sanctions.


