



ED/Hospital Self-Assessment Form For Designation of Levels of Care for Treating Overdose and Opioid Use Disorder

Instructions:

All emergency departments and hospitals in the state must complete this form in order to achieve certification in one of the three Levels of Care for treating overdose and opioid use disorder. Please complete this form, indicating whether your organization fulfills each component. Provide descriptions and required documentation for each component to demonstrate organizational compliance. Documentation should be specific and must reflect how your organization meets the required component.

Indicate if you require technical assistance from the standards leadership team of the Department of Health (RIDOH) and the Department of Behavioral Health, Developmental Disabilities and Hospitals (BHDDH), which is co-led by Elinore McCance-Katz M.D., PhD. and James V. McDonald M.D., M.P.H.

All forms and copies of necessary documentation should be submitted electronically to james.mcdonald@health.ri.gov. You may be contacted for clarification of component descriptions or documentation, and for arranging any site visits. The BHDDH/RIDOH standards leadership team will review the content and recommend level designation to the Directors of BHDDH and RIDOH. The Directors will publicly announce completion of certification processes and progress toward these goals will be tracked as part of PreventOverdoseRI.org for the Governor's Taskforce on Opioid Addiction and Overdose.

It is expected that every emergency department in Rhode Island will achieve at least Level 3 designation.
