### HIT SURVEY – PHYSICIANS

#### EMR Impact Detail Report, 2013

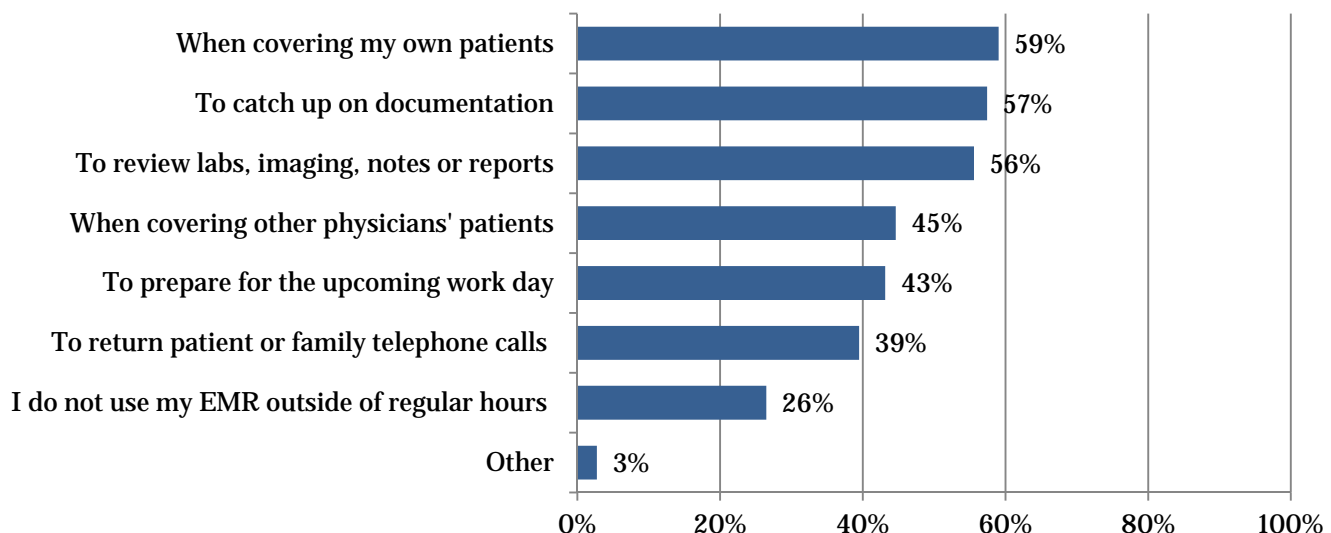
In early 2013, the Rhode Island Department of Health (HEALTH) administered the Physician HIT Survey to 3,799 physicians licensed in Rhode Island, in active practice, and located in Rhode Island, Connecticut, or Massachusetts. The response rate was 62.3% (n=2,367).

Survey respondents who indicated they use EMR were asked about how they use their EMR outside of regular work hours and if impacted their take-home workload. Respondents were also asked to think back to what their office or hospital was like before an EMR and indicate how much they agree or disagree with how an EMR has improved certain work related processes. Of those 2,367 respondents, 88.2% (n=2,087) already had an EMR. Some of the 2,367 physicians who completed the survey did not answer these questions.

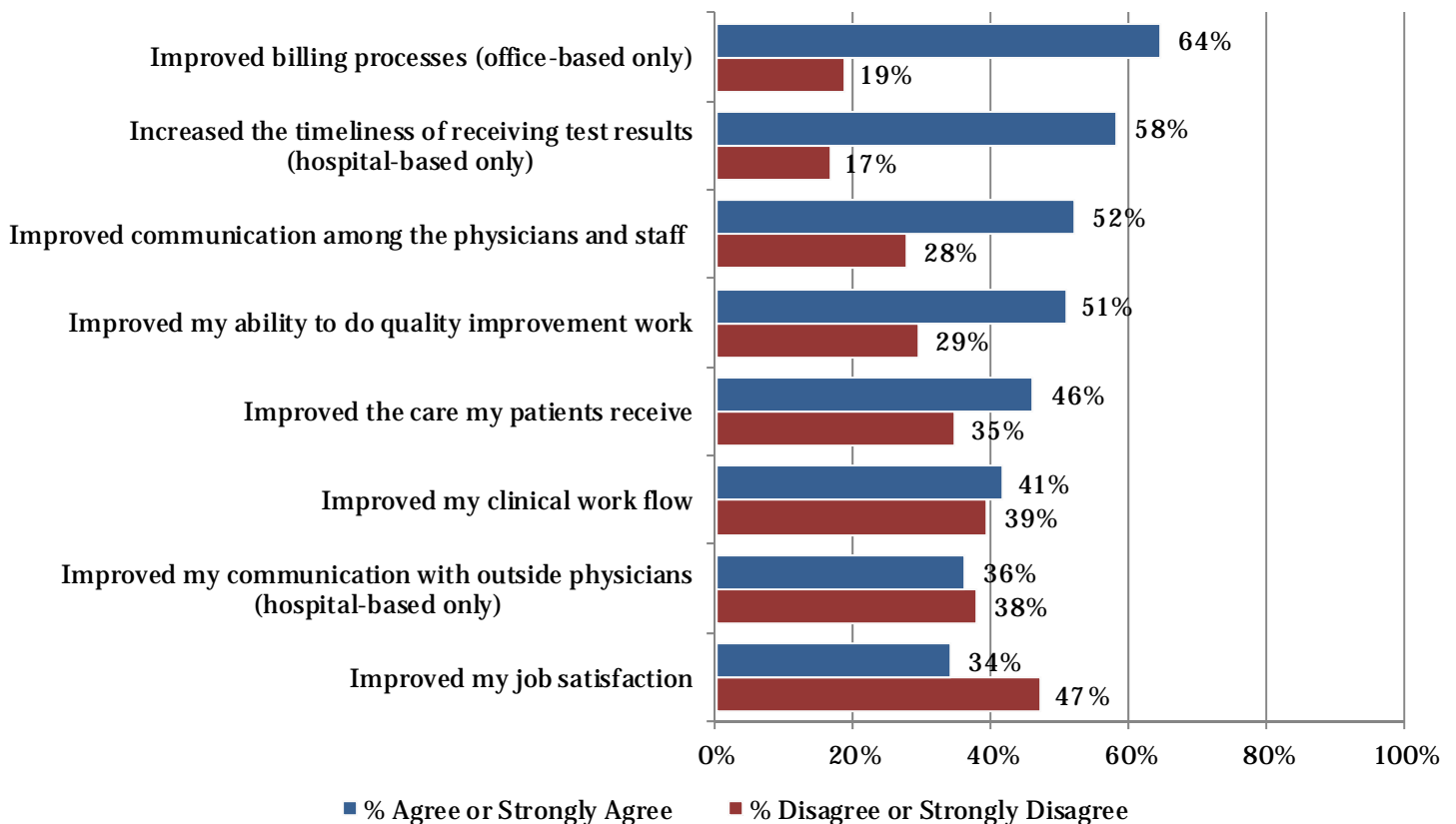
**Figure 1.** How do you use your EMR outside of regular work hours? (N=2,051)
