## NURSING ONLINE INITIAL APPLICATION REQUIREMENTS

1. Apply online at <https://healthri.mylicense.com>. Here you will complete an online application and pay the application fee (\$135.00 for RN and \$45.00 for LPN). Click Register a Person and follow the instructions to apply for a Registered or Practical Nurse license.
2. Please review the method in which you are applying and either submit or request the required documents. Documents provided by the applicant can either be emailed to [michele.monroe@health.ri.gov](mailto:michele.monroe@health.ri.gov) or mailed to the address listed above.

### **OBTAINED BY ENDORSEMENT**

These are the requirements if you have already taken the NCLEX Exam, and are licensed in another state.

**Proof of Rhode Island Residency** – **Proof is ONLY required if your primary residency is going to be in the State of Rhode Island.** Copy of driver's license, tax return or lease and MUST include Rhode Island address.

**Background Check With Fingerprints** - You must apply to the Department of Attorney General for a national background check supported by fingerprints. For information on this process please visit <http://www.riag.state.ri.us/homeboxes/BackgroundChecks.php> and click on National Background Checks. **Do NOT send the Fingerprint Card to the Rhode Island Board of Nursing.**

**License Verification**- You must request verification from all other state boards in which a license was issued. Verifications are done online at [www.NURSYS.com](http://www.NURSYS.com). If you have held a license in one of the following states (**AL, CA, HI and PA**) you must request a verification be sent directly to us from that state. **Please note** verifications from these states may take several weeks to be sent to us. You may obtain an Interstate Verification form on our website at [www.health.ri.gov/forms/NurseVerificationForm.pdf](http://www.health.ri.gov/forms/NurseVerificationForm.pdf). ### **OBTAINED BY EXAMINATION**

These are the requirements if you – need to take the NCLEX Exam, want Rhode Island as your primary state of licensure and have never been licensed in another

**Proof of Rhode Island Residency** – **Proof is ONLY required if your primary residency is going to be in the State of Rhode Island.** Copy of driver's license, tax return or lease and MUST include Rhode Island address.

**Official Transcripts** - Sent directly from the School of Nursing and must include graduation date and degree conferred

**Background Check With Fingerprints** - You must apply to the Department of Attorney General for a national background check supported by fingerprints. For information on this process please visit <http://www.riag.state.ri.us/homeboxes/BackgroundChecks.php> and click on National Background Checks. **Do NOT send the Fingerprint Card to the Rhode Island Board of Nursing.**

**Apply to NCSBN for the NCLEX Examination** - You must apply to the NCSBN to sit for the NCLEX examination by visiting their website at <https://www.ncsbn.org/index.htm> or by calling Toll-Free (866) 293-9600. ### **OBTAINED BY EXAMINATION – FOREIGN TRAINED GRADUATE**

These are the requirements if you have graduated from a nursing school outside of the United States and are **NOT** licensed in any other state.

**Proof of Rhode Island Residency** – Proof is ONLY required if your primary residency is going to be in the State of Rhode Island. **Copy of driver's license, tax return or lease and MUST include Rhode Island address.**

**Background Check With Fingerprints** - You must apply to the Department of Attorney General for a national background check supported by fingerprints. For information on this process please visit <http://www.riag.state.ri.us/homeboxes/BackgroundChecks.php> and click on National Background Checks. **Do NOT send the Fingerprint Card to the Rhode Island Board of Nursing.**

**Apply to NCSBN for the NCLEX Examination** - You must apply to the NCSBN to sit for the NCLEX examination by visiting their website at <https://www.ncsbn.org/index.htm> or by calling Toll-Free (866) 293-9600. Once you apply to the NCSBN Rhode Island must then make you eligible to take the test. You will not be made eligible until we receive your transcript from the school listing your graduation date and degree conferred.

**CGFNS- Foreign Trained Graduate** – Completion of the requirements of the Commission of Graduates of Foreign Nursing Schools. For information on this process please visit <http://www.cgfns.org/services>.

### **OBTAINED BY EXAMINATION - MILITARY**

These are the requirements if you need to take the NCLEX Exam, want Rhode Island as your primary state of licensure and have never been licensed in another state and you are active military duty, a military veteran with honorable discharge or the spouse of someone in active military or spouse of a reservist.

**Proof of Rhode Island Residency** – **Proof is ONLY required if your primary residency is going to be in the State of Rhode Island.** Copy of driver's license, tax return or lease and **MUST** include Rhode Island address.

**Official Transcripts** - Sent directly from the School of Nursing and must include graduation date and degree conferred

**Background Check With Fingerprints** - You must apply to the Department of Attorney General for a national background check supported by fingerprints.
