1. Welcome and roll call

1. Welcome and Roll Call

Brian Boates began the meeting by taking roll call at 9:00am.

2. Presentation of the September meeting minutes

Mr. Boates thanked everyone for joining the meeting and presented the September Data Security Subcommittee draft minutes. David Stuebe noted one error in the minutes and asked that the word "experts" be changed to "exports".

Mr. Stuebe motioned to approve the notes, Jon Fredrickson seconded the motion. All were in favor. The motion to approve the September Meeting Minutes was approved.

3. Review SE#22 Data Management Plan (Freedman HealthCare)

Mr. Boates recused himself from the meeting, as he disclosed a conflict of interest. Mr. Stuebe opened the discussion to review Freedman HealthCare's Data Management Plan and brought the meeting into executive session, stating: "I move,

pursuant to R. I. Gen. Laws § 42-46-5(a)(3), that this public body convene in executive session to discuss deployment of data security devises". Mr. Stuebe then muted the public comment line, in accordance with Executive Session Rules.
