**NOTICE OF VIOLATION AND COMPLIANCE ORDER**

This Notice of Violation and Compliance Order is issued pursuant to R.I. Gen. Laws § 23-1-20. William LaBarre, Emergency Medical Technician (EMT) License Number 08018, (Respondent) is licensed by the Rhode Island Department of Health, Center for Emergency Medical Services, (RIDOH) as License No.: EMT 08018 issued on January 21, 1994 and is required to comply with the provisions of R.I. Gen. Laws §23-4.1-1 *et. seq* and 216 RICR-20-10-2.

**FINDINGS OF FACT**


1. At all times relevant hereto, Respondent was licensed as an emergency medical technician, EMT License No. 08018, pursuant to R.I. Gen. Laws § 23-4.1-8 and 216-RICR-20-10-2.5(A)(B)(C) and (D).
2. On or about August 8, 2022, while Respondent was attending to a patient in his care, three North Smithfield police officers witnessed Respondent strike the patient's leg with a closed fist.
3. On or about August 8, 2022, while Respondent was attending to a patient in his care, one North Smithfield police officer witnessed Respondent state that he was going to kill the patient.
4. The conduct described in paragraphs three and four above constitutes unprofessional conduct in violation of R.I. Gen. Laws § 22-4.1-9 and 216-RICR-20-10-2.5(E)and (G).

**ORDER**

Respondent's EMT license is hereby SUSPENDED.

In accordance with R.I. Gen. Laws § 23-1-22, a written request for a hearing may be filed with Utpala Bandy, MD, MPH, Interim Director, Rhode Island Department of Health, c/o Legal Services, 3 Capitol Hill, Room 404, Providence, RI 02908 within 10 days of service of this notice. If a written request for a hearing is not made to the Interim Director within 10 days of the service of this notice, this notice shall become a compliance order by operation of law.
