VOLUNTARY AGREEMENT NOT TO PRACTICE MEDICINE

Jerrold Rosenberg, M.D. (hereinafter "Respondent") is licensed as a physician in Rhode Island. The Board of Medical Licensure & Discipline (hereinafter "Board") received the above referenced complaints and began an investigation.

FINDINGS OF FACT

1. Jerrold Rosenberg, M.D. (hereinafter "Respondent") has been a licensed physician in Rhode Island since December 2, 1987. His practice is located in North Providence, Rhode Island. He is a 1980 graduate of George Washington University of School of Medicine.
2. Respondent has active investigations (referenced above) by the Board open and at this time. Respondent chooses to enter into this agreement to Voluntarily Not to Practice Medicine. The Board will await the outcome in other jurisdictions before determining whether to resume its investigation into the above referenced matters. At that time, Respondent may petition the Board to void this agreement and

reinstate his license to practice medicine in the State of Rhode Island. In the event that the Board denies said Petition, Respondent retains all of his procedural and substantive rights under Rhode Island law to appeal from any decision by the Board refusing to void this agreement and reinstate Respondent's license to practice medicine in the State of Rhode Island.


Based on the foregoing, the parties agree as follows:

1. Respondent admits to and hereby agrees to remain under the jurisdiction of the Board.
2. Respondent has read this Voluntary Agreement Not to Practice Medicine and understands that it is a proposal and is subject to the final approval of the Director. This Voluntary Agreement Not to Practice Medicine becomes a public document and effective the day it is approved by the Director.
3. Respondent hereby acknowledges and, only with respect to this Voluntary Agreement not to Practice Medicine, waives:
 - a. The right to appear personally or by counsel or both before the Board;
 - b. The right to produce witnesses and evidence in his behalf at a hearing;
 - c. The right to cross examine witnesses;
 - d. The right to have subpoenas issued by the Board;
 - e. Any and all rights of appeal of this Voluntary Agreement Not to Practice Medicine;
 - f. Any objection to the fact that this Voluntary Agreement Not to Practice Medicine may be presented to the Board.

4. This Voluntary Agreement Not to Practice Medicine shall become part of the public record of this proceeding once it is approved by the Director, and it shall be reported to the National Practitioner Data Bank, the Federation of State Medical Boards and posted on the Rhode Island Department of Health web site.
5. This Voluntary Agreement Not to Practice Medicine becomes effective at 11:59 pm on May 12, 2017, allowing respondent time to close his practice in an orderly manner and arrange continuity of care for his patients.
6. The filling and/or refilling (after the effective date/time above) by patients of prescriptions properly written prior to the effective date/time above shall not constitute a failure to comply with this Agreement or otherwise subject the Respondent to any discipline by the Board.
7. The conduct of business and administrative functions, separate and apart from patient care, by Dr. Rosenberg and his employees, including but not limited to billing and collections activities, and responding to requests for records from patients, their duly appointed representatives or in response to lawful subpoenas after the effective date/time above shall not constitute a failure to comply with this Agreement or otherwise subject the Respondent to any discipline by the Board.
8. Failure to comply with Voluntary Agreement Not to Practice Medicine, when approved by the Director, shall subject the Respondent to disciplinary action.


this investigation and matters in other jurisdictions have been resolved.
