## **CONSENT ORDER**

Pursuant to R.I. Gen Laws §23-17.9-1 et seq. and the Rules and Regulations promulgated thereunder, 216-RICR-40-05-22, the Rhode Island Department of Health and the Nursing Assistant Advisory Board (collectively, "RIDOH") have investigated Complaint No. C22-1144 (the "Complaint") charging Juliana Silva Pereira, Temporary Nursing Assistant license number NA34192-T, ("Respondent") with violations of R.I. Gen Laws §23-17.9-1 et seq.

After review and consideration by RIDOH with respect to the allegations of unprofessional conduct of Respondent, the following are and shall constitute

## FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1. That Respondent is a Nursing Assistant licensed to practice in the State of Rhode Island under Temporary Nursing Assistant License Number NA34192-T.
- 2. That at all times relevant hereto, Respondent was employed by Trinity Health & Rehabilitation, 4 St. Joseph Street, Woonsocket, RI 02895.
- 3. On or about September 17, 2022, Respondent admitted to having posted a video of a patient assigned to her care on social media without permission or authorization.
- 4. That the conduct described in paragraph three (3) herein constitutes unprofessional conduct pursuant to R.I. Gen Laws §23-17.9-1 et seq. and the Rules and Regulations promulgated there under.
- 5. That Respondent admits to the jurisdiction of RIDOH and hereby agrees to remain under the jurisdiction of RIDOH.
- 6. That Respondent has read this Consent Order and understands this Consent Order shall become binding once signed by Respondent and RIDOH.
- 7. That Respondent understands the purpose of this Consent Order is solely to resolve the Complaint.

- 8. That Respondent hereby acknowledges and waives:
  - a) The right to have an administrative hearing on this matter;
  - b) The right to represent oneself or be represented by an attorney of Respondent's own choosing at said hearing;
  - c) The right to present testimony, evidence and witnesses on Respondent's behalf;
  - d) The right to cross-examine witnesses presented by RIDOH;
  - e) The right to further procedural steps except for those specifically contained herein;
  - f) The right to take an appeal from the terms of this Consent Order; and
  - g) Any objection that this Consent Order will be reported to the National Practitioner Data Bank as well as posted on RIDOH's public website.

## ACCORDINGLY, AND BASED ON THE FOREGOING

RIDOH and Respondent hereby agree to the following disposition of this Complaint:

- 9. Respondent is hereby issued the sanction of a Reprimand, starting the day this Consent Order is last executed.
- 10. Respondent acknowledges that this Consent Order is an agreement between Respondent and RIDOH.
- 11. This Consent Order shall become a permanent part of Respondent's record maintained by RIDOH and a part of a public record of this proceeding.
