## Virginia Graeme Baker Pool and Spa Safety Act Compliance Annual Attestation

**Licensing Aquatic Venues (216-RICR-50-05-4)**

Licensing Aquatic Venues (216-RICR-50-05-4) (the Regulations) Section 4.3.10 requires all licensed aquatic venues to demonstrate compliance with the *Virginia Graeme Baker Pool and Spa Safety Act*, 15 U.S.C §§8001-8003 (VGBA). It is incumbent on the licensee who operates an aquatic venue to determine the appropriateness of components and to demonstrate compliance with the VGBA. The VGBA in its entirety can be found here: https://www.poolsafely.gov/wp-content/uploads/2016/04/pssa.pdf. All public pools and spas (which includes hotels, motels, and apartment complexes) must have ANSI/APSP/ICC-16 2017-compliant drain cover(s) installed. A second anti-entrapment system is also required when there is a single blockable main drain or drains on the same plane that are less than three feet apart. By signing this form, the licensee attests that: the Rhode Island Department of Health (RIDOH) has advised the licensee of the requirements; and the licensee has reviewed their aquatic venue's compliance with the VGBA and determined all required components are installed and compliant.

I understand that even if the drain is compliant, the CPSC recommends replacement of drain covers that have passed the expiration date on the cover. I further understand that failure to operate in accordance with R.I. Gen. Laws §§ 23-22-1 through 23-22-15 and the Regulations promulgated thereunder may lead to penalties, fines, and/or closure of my licensed aquatic venue.
