## Introduction

This dictionary provides a list of available data elements — some as originally submitted, others as enhanced by Onpoint through review, standardization, and value-add processes. Elements are listed by table and provide technical specifications and background information, including inter-element mappings so users can plot the most efficient path to the data they need. Each dictionary table includes several columns as detailed below:

A few important notes about using the data described in this dictionary:

- **Field availability varies by type of Level 3 extract.** There are four versions of Level 3 extracts available from the State: medical eligibility and claims (extended), medical eligibility and claims (core), pharmacy eligibility and claims (extended), and pharmacy eligibility and claims (core). Depending on the Level 3 version(s) approved and provided by the State, some tables detailed in this dictionary may not be authorized for release. Additionally, date fields and ZIP codes subject to truncation have been color coded (orange) as a reminder and for faster identification by recipients of the Level 3 data sets.
- **Table order.** Data sets are listed in alphabetical order by common name. Note that the order of data elements in the tables below does not necessarily reflect their order in the released data sets and that assigned reference numbers may change as the data changes.
- **Code values of -1 and -2.** Many data sets include two codes that are necessary for the referential integrity of the warehouse: -1 (i.e., payer supplied no value) and -2 (i.e., payer supplied an incorrect or invalid value). These codes, whose values remain consistent throughout data sets, are value-adds and are not reported directly by data submitters.

## Duplicate Eligibility Reason Codes

The Duplicate Eligibility Reason Codes reference data set ([eligibility\\_duplicate\\_reason](#)) serves as a look-up table for all valid codes and values used to identify duplicate coverage for reported members.
