Condom Distribution

The Rhode Island Department of Health (RIDOH) operates a statewide condom distribution system. Individuals can obtain free condoms through our condoms by mail program or by visiting community organizations.



In 2020, RIDOH began a free condoms by mail program. A package of about 15 condoms will be sent directly to any address in Rhode Island in a discrete envelope. To request condoms for individuals, visit: www.health.ri.gov/findcondoms. Pocket cards with the link for free condoms by mail are also available in bulk for distribution.

RIDOH also provides free condoms to organizations that serve populations that are disproportionately impacted by sexually transmitted diseases. Needle Exchange and Resources for People Who Use Drugs

RIDOH contracts with AIDS Care Ocean State (ACOS) to operate a statewide needle exchange/drug user health program called ENCORE (Education, Needle Exchange, Counseling, Outreach, and Referrals).

They provide safe injection equipment (including sterile syringes), wound care kits, hygiene kits, condoms, naloxone, HIV/hepatitis C rapid testing, in addition to counseling and referral services. They have one fixed site located at 557 Broad St.

Providence, RI, 02907. In addition, they conduct street and mobile outreach throughout the state, home deliveries to any Rhode Island address, and their newest initiative is harm reduction vending machines (see next page).

Harm Reduction Vending Machines (HRVM)

AIDS Care Ocean State (ACOS) Prevention Center has created vending machines that are being used to dispense and distribute harm reduction supplies. These machines will be able to dispense free prevention and harm reduction tools including sterile needles, condoms, Naloxone (Narcan), wound care, hygiene supplies and fentanyl test strips. Many of the vending machines allow for 24/7 access for individuals who may be looking for supplies. To access the supplies in the machine individuals are asked to enroll with ACOS, then they can access any of the machines


Data and Surveillance



Hepatitis C, STD, HIV and TB Case Reporting

In accordance with state regulations, all cases of **Hepatitis C, HIV**, **Syphilis**, **Gonorrhea**, **Chlamydia**, and **Tuberculosis** are required to be reported to the RIDOH within **4 Days** of recognition or suspicion of infection using the corresponding case report form. Also, RIDOH requires the reporting of pregnancies among people living with these infectious diseases.

TESTING 1-2-3

RIDOH has created an online HIV, STI and Hepatitis C testing system called TESTING 1-2-3 that promotes regular HIV, STI and Hepatitis C testing by use of a user-friendly website. This site helps residents



Hepatitis C testing by use of a user-friendly website. This site helps residents set up HIV, STI, and Hepatitis C testing appointments in 3 easy steps. Residents simply complete an online form, go to the lab of their choice for testing, and await their results by secure email or phone. Note that TESTING 1-2-3 is for asymptomatic testing only and is typically covered by insurance, but it is not free. If residents are symptomatic, they should visit provider locations listed on the TESTING 1-2-3 website.

Partner Services

RIDOH provides services to assist individuals who have HIV, Syphilis, Gonorrhea and Chlamydia to contact their partners to facilitate testing. These services are provided in conjunction with health care providers. Providers may also advise patients to utilize the RIghtTime app or www.tellyourpartner.org (which powers the notification tool on the RIghtTime app) to notify partners of STD exposure via anonymous text or email.

Expedited Partner Therapy

As of 2010, Expedited Partner Therapy (EPT), has been offered to Rhode Island Residents. EPT can be used to ensure effective partner treatment and help prevent reinfection. Currently, lack of effective partner treatment is the greatest risk factor for Chlamydial and Gonococcal reinfection.

HIV Return to Care

Clinical medical providers and non-clinical case management agencies who care for people living with HIV may refer patients who have fallen out of care for assistance by RIDOH staff in locating and re-engaging patients.



Providers should complete the HIPAA-compliant <u>RIDOH HIV Return to Care Patient</u> <u>Referral Form</u>, for all HIV patients who have not been seen or have not had a lab test within the last 6 months. This form should be mailed to the provided address at RIDOH.

Uber Health

RIDOH now offers Uber Health! Clinical providers may reach out to the RIDOH team to request a ride at no cost to the patient, for any patient diagnosed with Tuberculosis, Hepatitis C, HIV, and/or Sexually Transmitted Diseases, who may need help getting to and from a medical appointment. Appointments must be related to the testing, treatment and/or follow-up of those infections.

Uber Health is a HIPAA-compliant way of requesting rides, and ensures that patients can get to their appointments in a timely manner. The only information that is shared with the Uber driver is the patient's first name, pick-up location and destination, and drivers are unaware that the health department has requested the ride, further improving patient privacy.

*Please note that all Uber Health rides are subject to approval by the Field Services Manager and are only available for patients diagnosed with HIV, HCV, STD or non-infectious TB.

Rhode Island's Confidentiality of Health Care Communications and Information Act

The Confidentiality of Health Care Communications and Information Act, R.I. Gen. Laws § 5-37.3-12, § 5-37.3-12, went into effect on Jan. 1, 2022. The goal of this Statute is to ensure that all individuals have access and adequate privacy in their healthcare and documentation of healthcare services.

Many insurance companies routinely send Explanations of Benefits (EOB) to the policyholder's home address when a subscriber on the plan receives a healthcare service. The EOB describes the service and lists the service provider. By default, the EOB is sent to the policyholder's mailing address.

Under this law, health insurers (not including self-insured plans) are required to offer a confidential communications request form to be easily readable and prominently displayed on the health insurer's website. This form allows an insured person to request any medical information sent by an insurer to be communicated to an alternate address, secure email address, or alternate phone number, so it is sent directly to the patient who received the service instead of the policyholder.

RISE Clinic

The RISE Clinic is the state-funded TB clinic in Rhode Island. Patients with suspect or confirmed TB disease or LTBI (Latent Tuberculosis Infection) can be referred to the RISE Clinic for specialty care. The RISE Clinic is a referral only clinic; walk-ins and patient self-referrals are not accepted.



To refer a patient to the RISE Clinic, the provider must complete <u>the referral</u> <u>form</u>, confirm the appointment time with the patient, and fax the form to the RISE Clinic. Contact the RISE Clinic to obtain available appointments and facilitate appropriate triage.

The RISE Clinic will triage the patient. If you suspect that the patient has active TB and/or an abnormal chest x-ray, you must speak with the RISE Clinic physician to discuss the case. The RISE staff will then collect any pertinent information so that the patient can be seen as soon as possible.

Directly Observed Therapy (DOT) Program

Directly observed therapy (DOT) is the standard of care for all TB disease cases in the state. Upon receiving a report of a new TB disease case and a prescription from the TB clinician for the case, the TB Program will match the case with a DOT outreach worker based on culture and language needs. Every treatment dose will be administered to the patient under direct observation by the DOT outreach worker.
